Zenith Minerals Limited (“Zenith” or “the Company”) (ASX: ZNC) confirms it has completed the capital raising previously announced on 7 July 2020, to raise \$5,100,000 via the placement of 51,000,000 fully paid ordinary shares (“Shares”) at \$0.1 per Share to existing shareholders and sophisticated investors pursuant to s708 of the Corporations Act (Cth) 2001, together with 2,000,000 premium priced unlisted options, each with an exercise price of \$0.14 and an expiry of 31 December 2023 and 2,000,000 premium priced unlisted options, each with an exercise price of \$0.16 and an expiry of 31 December 2023 (“Options”) (“Placement”).

The Company confirms that 51,000,000 Shares and 4,000,000 Options have been issued on 13 July 2020 in respect of the Placement.

The Company advises that it is currently in ongoing and incomplete negotiations in connection with a number of potential project acquisitions and disposals, including new exploration tenure in New South Wales, possible divestment of its Laramie REE project in Wyoming and renegotiation of its American Lithium JV in the USA. These discussions are ongoing, and no agreement has been entered into, and it is currently unknown when or if agreements will be completed. Additionally, new tenure applications have recently been lodged in Queensland. The Company will provide appropriate disclosure should negotiations and agreements be completed, and new tenure granted.
